Moduline Type R concentric shaft speed reducers reflect many years of experience in gearing products. We utilize the flexibility of the modular concept and provide readily available drives, tailored to popular horsepower selections for actual applications having output torque requirements up to 230,000 in-lbs.

Moduline speed reducers are designed in accordance with all applicable AGMA standards and Nuttall Gear's value added design engineering capabilities. Standard ratios provide a broad range of output speeds to fit most applications.

The removable high speed end facilitates ratio changes or other servicing. Moduline Type R Speed Reducers can be driven by electric motors, gasoline engines, diesel engines, power take-off shafts and line shafts. They may be directly connected by a coupling or offset by means of a chain and sprocket or belt and pulley.

Moduline Speed Reducers can be designed for floor, ceiling, vertical or angled (up to 26°) mounting positions.


